3. Call O.K.I.E. (1-800-522-6543) at least 48 hours before doing any excavation work.
4. Certificate of occupancy must be issued before any utilities can be turned on.
5. This permit is issued to and accepted by the applicant upon representation that the proposed improvements will be made in conformity with and under the provisions of the City ordinances, regulations, and codes covering land use, zoning, subdivisions, building, plumbing, electrical, natural gas, construction, and all other codes and ordinances relating to buildings, and any and all parts of the master plan of the City of Ada, Oklahoma, and it is agreed that this permit shall be void if said improvements fail to comply with any part of this application.
