## Discussion of and action on request from Ada Main Street for temporary street closures and assistance with traffic and crowd control during the "Pat Taylor Memorial Parade of Lights" on Thursday, December 4, 2014

City Manager Holcomb reported Ada Main Street was requesting to close streets, beginning at 4:00 p.m. on Thursday, December 4th, to prepare for the annual Pat Taylor Memorial Parade of Lights. City Manager Holcomb also reported City's assistance had been requested for the placing of barricades along the parade route, and for assistance with traffic and crowd control beginning at 4:00 until the parade traffic clears.

# Discussion of and action on approval of Agreement with CEC Infrastructure Solutions to provide a drainage study for East Main Street from North Mississippi to North Constant

City Manager Holcomb presented the proposed Agreement, explaining the Agreement would provide a drainage study and analysis of the area of East Main Street experiencing flooding at low points east of North Constant. The City Manager stated the cost is a lump sum amount of \$9,510.00 and would be funded from Proposition One.

Motion was made by **Councilman Nemecek** and seconded by **Councilman Sewell** to approve Agreement with CEC Infrastructure Solutions to provide a drainage study for East Main Street from North Mississippi to North Constant. Mayor Morris called for the vote recorded as follows:

# for improvements to the Ada Municipal Airport and authorization for the Mayor to execute all necessary documents to issue the Notice to Proceed.

City Manager Holcomb reviewed with the Council, the Amendments to the contract with Delta Airport Consultants, stating the actual construction of these improvements will be planned for the fiscal year 2015-2016 budget. Mr. Holcomb advised the amendments, if approved, would replace the failing runway lights, design the expanded new terminal apron, provide a seal coat for the existing runway, and improve the grading in the immediate vicinity of the runway edge.

City Manager Holcomb advised the City Attorney was available to answer questions concerning the pending law suit against EST, Inc., and C3 Construction, Inc.

Mayor Morris stated he would abstain from voting on this matter, as his law firm has C3 Construction, Inc., as a client.

Motion was made by **Councilman Sewell** and seconded by **Councilman McFarlane** to authorize filing suit against EST, Inc., C3 Construction, Inc., and any other person, firm, or corporation who is or may be liable for damages to the City of Ada, Oklahoma, arising out of or pertaining to the Wintersmith Park, Ada City Lake Dam Spillway Apron Rehabilitation, and for such other relief as may be authorized by law. Mayor Morris called for the vote recorded as follows:
