## CITY OF ADA REGULAR MEETING DECEMBER 15, 2014

The Ada City Council met in regular session, Monday, December 15, 2014 at 5:45 p.m. at City Hall in the Dr. Ray L. Stout City Council Chamber. Advanced public notice was given by posting the agenda on the City Hall bulletin boards on Friday, December 12, 2014 at 4:35 p.m.

Vice Mayor Darrell Nemecek gave the invocation.

Public Information Director, Lisa Bratcher, presented certificates and checks to the Christmas Lighting contest winners, sponsored by Citizens Bank.

# Discussion of and action on approval to surplus Inventory Item Number 011098 (Trimble Geo-XT GeoExplorer) and use it as a trade-in on new equipment

Motion was made by **Councilman McCortney** and seconded by **Councilman Nemecek** approving to surplus Inventory Item Number 011098, Trimble Geo-XT Geo Explorer and use it as a trade-in on new equipment. Mayor Morris called for the vote recorded as follows:

Discussion of and action on approval of Lease between the City of Ada and Ada Hobos, Inc. from January 1, 2015 to June 30, 2017 in the sum of \$2000.00 per year, for the following property, and authorization for the Mayor to execute said Lease, for the following property:

# The Southwest Quarter of the Northeast Quarter (SW/4 NE/4) of Section 34, Township 2 North, Range 6 East, Pontotoc County, State of Oklahoma.

City Manager Holcomb advised this proposed Lease for property owned by the City downstream from Byrd's Mill Spring, has been leased by Ada Hobo's for many years. City Manager Holcomb reported the City had held an auction for leasing the property and the only bidder was the Ada Hobo's, at \$2,000 per year.

Motion was made by **Councilman Nemecek** and seconded by **Councilman McFarlane** to accept the bid from Ada Hobos, Inc.

City Attorney Stout advised the motion needed to include approval of the Lease agreement.

**Councilman Nemecek** amended his motion to include approval of Lease between the City of Ada and Ada Hobos, Inc. from January 1, 2015 to June 30, 2017 in the sum of \$2000.00 per year, for the following property, and authorization for the Mayor to execute said Lease, for the following property: The Southwest Quarter of the Northeast Quarter (SW/4 NE/4) of Section 34, Township 2 North, Range 6 East, Pontotoc County, State of Oklahoma. The motion was seconded by **Councilman McFarlane**. Mayor Morris called for the vote recorded as follows:

Discussion of and action on approval of Contract for Sale of Real Estate with J. Brock Barrett and Gena Nicole Barrett for the purpose of purchasing real property for the sum of \$71,000.00; authorization for Mayor to execute said contract and all other documents required for the closing of the purchase of said real property; said real property being described as:

# Lot 20 of Block 113, Original Townsite of the City of Ada, Pontotoc County, State of Oklahoma, also known as 218 West 14<sup>th</sup> Street, Ada, Oklahoma

City Manager Holcomb reported the purchase of this property on West 14<sup>th</sup>, located near the site of the new police station would allow the City flexibility and options for future development and growth, and the cost of \$71,000.00 would come from the Use Tax Fund.

Motion was made by **Councilman McCortney** and seconded by **Councilman Sewell** to approve Contract for Sale of Real Estate with J. Brock Barrett and Gena Nicole Barrett for the purpose of purchasing real property for the sum of \$71,000.00; authorization for Mayor to execute said contract and all other documents required for the closing of the purchase of said real property; Lot 20 of Block 113, Original Townsite of the City of Ada, Pontotoc County, State of Oklahoma, also known as 218 West 14<sup>th</sup> Street, Ada, Oklahoma. Mayor Morris called for the vote recorded as follows:

Discussion of and action on approval of Donation Agreement between Wells Fargo Bank, N.A. and the City of Ada, Oklahoma, and authorization for Mayor to execute said Donation Agreement, and authorization for City Attorney to execute all required forms to close said transaction for the following described real property:

> All of lots 5 and 6, in Block 75 of the Original Townsite, Pontotoc County, Oklahoma, also known as 321 West 8th Street, Ada, Oklahoma

City Attorney discussed the property Wells Fargo Bank wants to donate to the City of Ada. The City Attorney advised this transfer of property would not cost the city anything, and is possible the property could be included in some type of development of "affordable housing" once the program begins.

Motion was made by **Councilman Nemecek** and seconded by **Councilman McFarlane** to approve Donation Agreement between Wells Fargo Bank, N.A. and the City of Ada, Oklahoma, and authorization for Mayor to execute said Donation Agreement, and authorization for City Attorney to execute all required forms to close said transaction for the following described real property: All of lots 5 and 6, in Block 75 of the Original Townsite, Pontotoc County, Oklahoma, also known as 321 West 8th Street, Ada, Oklahoma. Mayor Morris called for the vote recorded as follows:
