- 1. The meeting of the Ada City Council was called to order by Mayor McFarlin.
- 2. The audience was led in the Pledge of Allegiance by Mayor McFarlin.
- 3. The audience was asked to observe a moment of silence by Mayor McFarlin.

6. Public Hearing and discussion of and action on a Resolution authorizing the use of certain property in a C-2, General Commercial District within the City of Ada for a use permitted on review for mini-warehouses/storage units in an existing building for the following described property:

All of Lot 9, Block 98, of the original townsite of Ada, Pontotoc County, Oklahoma. This property is known as 117 West Main.

Staci Bungard, Community Development Director for the City of Ada, addressed the council on the applicant's request for 117 W. Main; planning and zoning meeting outcomes and the staff recommendations.

Mayor McFarlin asked the applicant if they would wish to address the council. Mr. Larry Lackey, owner of 117 W. Main addressed the council on the use of the building for the proposed climate-controlled mini-storage on the ground floor with the apartment living quarters on the 2nd floor.

Council Members Hudson and Johnson inquired about hours of operation and signage. Council Member Vazquez inquired about the number of units available. Council Member Griffith inquired about the frequency of inspections. Council Member Johnson inquired if the use is not approved, will the applicant continue with the building renovation and apartments for the 2nd floor.

Mayor McFarlin asked the audience if anyone would like to speak in favor of the proposed use for the mini-storage units on Main Street. Michael McElroy, 803 E. Main addressed the council on the favorable use of the property as indoor mini-storage units.

Mayor McFarlin asked the audience if anyone would like to speak in opposition of the proposed use for the mini-storage units on Main Street.

Amy Kaiser, 101 W. 22nd addressed the council as a member of the Council on Restoration Business Improvement Grant and Ada Main Street opposing the use of the property for indoor mini-storage units.

Amy Elliott, 1402 Kerr Research Dr. addressed the council as representative of the Betty Childers Trust, opposing the use of the property for indoor mini-storage units.

Jenny Cypert, 1711 Vinehaven, inquired about sales tax collections on storage units.

Eric Dyer, 116-118 W. Main addressed the council opposing the use of the property for indoor mini-storage units.

Sarah Johnson, 1204 Constant, addressed the council on possible dual use of the property for retail and the indoor mini-storage.

Motion made by council member Hudson to approve a Resolution authorizing the use of certain property in a C-2, General Commercial District within the City of Ada for a use permitted on review for mini-warehouses/storage units. Motion dies for lack of a second.
