I hereby apply for water, sewer, garbage and line charge, where applicable at _____
(address) only, in accordance with the rules and regulations of the City Utilities Department. In
consideration of the furnishing of such services to me at the above address I (we) hereby agree to the
following terms and conditions:

1. That all the Ordinances of the City of Ada, Oklahoma, constitute a part of this contract by reference and that I will abide by the provisions thereof, including any amendments that may be made thereto.
2. To pay for such services at the Ordinance rate and within the days allowed. The bill for water and sewer services shall be based on the quantity of water passing through the meter. The bill for garbage service shall be based upon the rate established from time to time by the City Council.
3. To notify the City Utilities Department when moving or leaving the premises. I understand that I will be responsible for all services furnished prior to such notification, including any minimum charges which may apply.
4. To make suitable guarantee for the payment of such bills by a monetary deposit.
5. To make no claims against the City of Ada Oklahoma, its agents, servants or employees, for penalty or discount for failure on the part of the City to timely deliver a statement for utility charges. I understand that all charges are to be paid at the office of the City Utilities Department in accordance with the City Ordinance, or at such other location as may be designated by the City Utilities Department.
6. To further effectuate the term of this agreement I (we) hereby covenant to indemnify protect and save harmless the said City from all claims from damages occasioned by the bursting, blockage or leakage of any of the pipes used for supplying of water or the transportation of sewage under this application and for any claims arising out of failure to supply water or failure to provide sewer service, including, but not limited to, damages arising directly out of the release of water or sewage upon the premises described above.
7. To comply with all Ordinances now in forces or that may be hereafter enacted concerning the installation, laying, connecting, plumbing or repairing of all water, sewer, drain or waste lines or pipes, and agree that inspectors designated by the City of Ada, at any and all times may enter upon my premises for the purpose of making inspections of plumbing as provided by the Ordinances of the City of Ada and if at any time it is found that I have not complied with said ordinances, then all services to me may be discontinued upon the order of the City Utilities Department without notice tome until compliance has been made and a receipt showing inspection and approval is presented to the City Utilities Department.
8. That utility service will not be initiated for me if I owe any past due balance to the City of Ada for water, sewer or garbage services furnished at this or any other location until all previous balances are paid in full.
9. It is expressly agreed that the City reserves the right to abrogate this contract as to customers located outside the corporate limits of the City at any time the City Council shall, by resolution duly adopted declare that the water being furnished under this contract is required by such city for the use of its own inhabitants.
10. If default shall be made by the customer in any of the terms of this agreement or if payments are not punctually made, or if the Regulations or Ordinances of the City are in any respect violated the City Utilities Department May Disconnect the Water Services at my expense and charge me according to the said regulations and ordinances, with which I am duly familiar.
