CITY OF ADA REGULAR MEETING DECEMBER 21, 2020

The Ada City Council met in a regular meeting, Monday, December 21, 2020 at 5:45 p.m., at Ada City Hall, in the Dr. Ray L. Stout City Council Chamber, 231 S. Townsend. Advanced public notice was given by posting the agenda on the City Hall bulletin board on Friday, December 18, 2020 at 2:25 p.m., and posting on the City of Ada web site Friday, December 18, 2020.

The meeting of the Ada City Council was called to order by Mayor Landrum.

Mayor Landrum led the audience in the Pledge of Allegiance.

Mayor Landrum called for a moment of silence to be observed.

Discussion of and action on Consent Agenda

Discussion of and action on items removed from the Consent Agenda

There were no items removed from the Consent Agenda.

Discussion of and action on a resolution approving the partial vacation of the plat of Grindstaff's Subdivision of Tract 13, Hillsdale Estates, Suburban Townsite to Ada, Pontotoc County, Oklahoma, insofar as pertains to Lots 3,4,5, and 6 of said subdivision; and authorizing the Mayor to execute all necessary documents in regard thereto

City Manager Holcomb presented the resolution for consideration, stating the partial vacation of a plat in the Grindstaff Subdivision, for Lots 3, 4, 5, and 6 had been requested by Duane Murray. The City Manager advised Mr. Murray is planning to build a new home on the property.

Attorney, Alvin Files, representing Mr. Murray, addressed the Council Members, informing them all property owners of the lots in the subdivision have indicated their consent to this partial vacation.

Motion was made by Councilman McFarlin, seconded by Councilman Sewell to adopt Resolution No. 20-22A, a resolution approving the partial vacation of the plat of Grindstaff's Subdivision of Tract 13, Hillsdale Estates, Suburban Townsite to Ada, Pontotoc County, Oklahoma, insofar as pertains to Lots 3, 4, 5, and 6 of said subdivision; and authorizing the Mayor to execute all necessary documents in regard thereto. Mayor Landrum called for a vote taken with the following result:

Discussion of and action on bids for Concrete Panel Replacement Project

City Manager Holcomb advised the purpose of the bid is to acquire a price for providing concrete panel replacements to four (4) designated streets selected during the street evaluation process. Mr. Holcomb advised city staff recommends the bid from MTZ Construction, Inc., a construction company, who did previous work in the City on the Oak Street Project and did a good job.

Motion was made by **Councilman Sewell**, seconded by **Councilman McFarlane** to approve the awarding the bid to MTZ Construction, Inc., Oklahoma City, as the lowest responsible bid, in the

amount of \$158,156.56 for Concrete Panel Replacement Project. Mayor Landrum called for a vote taken with the following result:

Discussion of and action on bids for concrete

City Manager Holcomb advised this bid is intended to provide fixed prices for concrete through June 30, 2021. The City Manager advised sealed bids were received December 8, 2020, and Rustin Concrete was the only bidder.

Motion was made by **Councilman Morris**, seconded by **Councilman McFarlane** to award the bid for concrete to Rustin Concrete as the lowest responsible bid. Mayor Landrum called for a vote taken with the following result:

Discussion of and action on bids for material hauling

City Manager Holcomb reported three bids had been received to provide the hauling of rock and other materials from the providing vendors to designated job sites. The City Manager advised the bid is based on per ton calculations for the amounts corresponding to three specified distances. City Manager Holcomb advised City Staff recommends Cowboy Trucking as the lowest responsible bid.

Motion was made by **Councilman Morris**, seconded by **Councilman McFarlin** to award the bid to Cowboy Trucking, as the lowest responsible bid. Mayor Landrum called for a vote taken with the following result:

Discussion of and action on bids for mineral aggregate

City Manager Holcomb advised four (4) bids had been received, but no vendor has the lowest price across the board, so recommendation is to continue to split the bid.

Motion was made by **Councilman Sewell**, seconded by **Councilman McFarlin** to award the bid for Type W Aggregate Base to Vulcan Materials Co., as the lowest responsible bid, and award to

Dolese Brothers – Davis for Type II Microsurfacing and Course Aggregate Fill, as the lowest responsible bid for mineral aggregate. Mayor Landrum called for a vote taken with the following result:
