The Ada City Council met in regular session, Monday, December 17, 2018 at 5:45 p.m. at City Hall in the Dr. Ray L. Stout City Council Chamber. Advanced public notice was given by posting the agenda on the City Hall bulletin boards on Friday, December 14, 2018 at 3:00 p.m.

Mayor Tre' Landrum called the meeting to order at 5:45 p.m.

Mayor Landrum led the Pledge of Allegiance.

Discussion of and action on an ordinance closing to public use a certain public easement and/or right-of-way, as more particularly hereinafter described, located in the City of Ada, Pontotoc County, Oklahoma; and declaring an emergency for the following described property:

A tract of land being the alley in Block One (1) in the recorded plat of Oak Hills Addition, City of Ada, Pontotoc County, Oklahoma, more particularly described as follows: Beginning at the southwest corner of Lot One (1) in said Block One (1); thence N 89°30'22" E (Basis of Bearing) along the south line of Lots One (1) through Five (5) in said Block One (1), a distance of 254.90 feet to the southeast corner of said Lot Five (5); thence N 00°46'30" W along the east line of said Lot Five (5), a distance of 8.40 feet to the southwest corner of Lot Six (6) in said Block One (1); thence N 89°30'22" E along the south line of said Lot Six (6) a distance of 50.14 feet to the southeast corner of said Lot Six (6); thence S 00°46'30" E a distance of 32.80 feet to the northeast corner of Lot Seven (7) in said Block One (1); thence S 89°30'22" W along the north line of said Lot Seven (7), a distance of 50.22 feet to the northwest corner of said Lot Seven (7), said point being on the East line of Lot Eight (8) in said Block One (1); thence N 00°46'30" W along the east line of said Lot Eight (8), a distance of 8.40 feet to the northeast corner of said Lot Eight (8); thence S 89°30'22" W along the north line of Lots Eight (8) through Twelve (12) in said Block One (1), a distance of 254.82 feet to the northwest corner of said Lot Twelve (12); thence N 00°46'39" W a distance of 16.00 feet to the point of beginning. Said tract having an area of 5723.64 Square Feet, 0.131 acres, more or less.

City Attorney Frank Stout reported he had spoken with the law firm requesting the closure, and they will execute an easement back to the City for the utilities present in the alley.

Motion was made by Councilman Morris, seconded by Councilman McFarlin to accept the bid from JPMorgan Chase, Option B at 3.17%, callable at five years, 1/1/2024, and to adopt Resolution No. 18-25A, a resolution of the City of Ada, Oklahoma (the "City") approving the incurrence of indebtedness by the Ada Public Works Authority (the "Authority") issuing its Utility System Revenue Note, Series 2018 (the "2018 Note"); providing that the organizational document creating the Authority is subject to the provisions of the Indenture authorizing the issuance of the 2018 Note; waiving competitive bidding with respect to the sale of the 2018 Note and approving the proceedings of the Authority pertaining to the sale of the 2018 Note; ratifying and confirming an amended Lease Agreement and Operation and Maintenance Contract between the Authority and the City; establishing the City's reasonable expectation with respect to the issuance of tax-exempt obligations by or on behalf of said City in Calendar Year 2018, and designating the Note as a qualified tax-exempt obligation; and containing other provisions relating thereto.
