Mr. Nate Atchison of Finley & Cook presented the annual audit report for fiscal year ending June 30, 2014. He rendered a clean opinion on the financial statements. He commended the City's staff on their financial management. A motion was made by **Councilman McCortney** and seconded by **Councilman Nemecek** to accept the City of Ada's annual audit for fiscal year ending June 30, 2014. # Discussion of and action on a resolution establishing water, sewer and solid waste fees and charges as provided by the Code of Ordinances of the City of Ada, Oklahoma

City Manager Holcomb discussed the resolution containing the increased garbage rates. The City Manager advised the City's contract with WCA authorized to implement the annual Consumer Price Index rate adjustment effective for services rendered beginning December 1<sup>st</sup>. Mr. Holcomb reported their rate increase would be 1.7%, but the fee resolution reflects a 5% increase in garbage rates, with the excess funds used for positioning the City to cover the cost of the current provided services, and to include funds for the future services to be provided such as large recycling containers, new transfer station, and the purchase of necessary equipment.

Motion was made by **Councilman McFarlane** and seconded by **Councilman Nemecek** to adopt **Resolution No. 15-02A**, a resolution establishing water, sewer and solid waste fees and charges as provided by the Code of Ordinances of the City of Ada, Oklahoma. Mayor Morris called for the vote recorded as follows:

## **Reports by City Manager**

City Manager Holcomb reported on the successful results of the election to extend the "Penny for our City" sales tax. Mr. Holcomb applauded the efforts of those who participated in campaigning for support of the extension of the sales tax.
