CITY OF ADA REGULAR MEETING MARCH 6, 2017

The Ada City Council met in regular session, Monday, March 6, 2017 at 5:45 p.m. at City Hall in the Dr. Ray L. Stout City Council Chamber. Advanced public notice was given by posting the agenda on the City Hall bulletin boards on Friday, March 3, 2017 at 1:55 p. m.

Mayor Sewell called the meeting to order at 5:45 p.m.

Mayor Sewell led the audience in the Pledge of Allegiance.

Vice Mayor Preston Draper gave the invocation.

Discussion of and action on Consent Agenda

Discussion of and action on items removed from the Consent Agenda

There were no items removed from the Consent Agenda.

Discussion of and action on approval of the preliminary plat for a single-family residential subdivision to be known as "Arbor Creek Addition" to be located on the following described property:

A tract a part of the SW/4 of NE/4 of Section 15, Township 3 North, Range 6 East, more particularly described as follows: commencing at the northwest corner of the SW/4 of NE/4 of said Section 15; thence S 00°44'30" E a distance of 363.09 feet to the point of beginning; thence N 89°33'29" E a distance of 600.00 feet; thence N 00°44'30" W a distance of 363.00 feet, thence N 89°34'00" E a distance of 722.68 feet to the northeast corner of said SW/4 of NE/4; thence S 00°45'26" E a distance of 1320.53 feet to the southeast corner of said SW/4 of NE/4; thence S 89°34'44" W a distance of 1323.05 feet to the southwest corner of said SW/4 of NE/4; thence N 00°44'30" W a distance of 957.16 feet to the point of beginning, containing 35.10 acres, more or less.

This property is located south of Pre-Paid Way and Stonecipher Boulevard intersection.

City Manager Cody Holcomb provided information concerning the request of Mr. Darren Bond to approve a preliminary plat for the Arbor Creek Addition, an un-platted parcel of land located in the city limits on the south side of the intersection of Pre-Paid Way and Stonecipher Boulevard. Mr. Holcomb reported Mr. Bond was proposing to subdivide the property into 29 single family residential building sites, currently zoned R-1, One-Family Residential. The City Manager advised the developer will be required to construct all streets to city specifications for dedication to the City, to provide an extension of the main water line to the Addition, and all lots would be served individually by their private aerobic systems approved by DEQ.

Community Development Director, Roger Abbott, spoke to the Council concerning two areas city staff would be working with the developer, specifically the raw water line that crosses this property, and providing protection for the City's water line.

Motion was made by **Councilman McFarlane**, seconded by **Councilman Morris** to approve the preliminary plat for a single-family residential subdivision to be known as "Arbor Creek Addition", located south of Pre-Paid Way and Stonecipher Boulevard intersection. Mr. Holcomb explained Hangar H at the Ada Regional Airport was originally leased to Durr Building Company on May 21, 2001, with an additional subsequent lease extension on October 15, 2012. City Manager Holcomb advised Durr Building Company is now seeking the City's approval to assign their interest in said lease and extension to Heartland Aviation. Mr. Holcomb stated there were several years left on the lease, and at the expiration of the lease Hangar H would revert to the City of Ada.

Motion was made by **Councilman McFarlane**, seconded by **Councilman Landrum** to approve Assignment and Assumption of Lease between Durr Building Company, Inc. and Heartland Aviation, LLC of the Lease Agreement dated May 21, 2001 and subsequent Lease Extension Agreement dated October 15, 2012 for Hangar H at the Ada Regional Airport. Mayor Sewell called for the vote recorded as follows:
