The Ada City Council met in regular session, Monday, August 4, 2014 at 5:45 p.m. at City Hall in the Dr. Ray L. Stout City Council Chamber. Director of Community Development, Todd Kennemer, addressed the Council. Mr. Kennemer reported on the progress of the property owner at 1201 Sandy Creek Drive. He requested no action taken on this resolution.

Discussion of and action on a resolution finding that the main dwelling located at 901 South Broadway, Ada, Pontotoc County, Oklahoma is dilapidated and a nuisance; that the property would be benefited by the removal of the building; ordering that the dilapidated building be torn down and removed; fixing dates for commencement and completion of the work; and authorizing the City Attorney to file suit in the District Court for abatement of the nuisance existing on the property

Mr. Kennemer addressed the Council concerning the property at 901 South Broadway. He reported there had been no additional repairs to the structure since it had last been before the Council on December 16, 2013, and the resolution rescinded.

Public hearing and discussion of and action on an ordinance providing for the re-zoning of certain property within the City of Ada, Oklahoma, from A-2, Suburban District, to C-2, General Commercial District, and declaring an emergency for the following described property:

A tract of land in the SE/4 of SE/4 of NW/4 of Section 16, Township 4 North, Range 6 East, more particularly described as follows: Beginning at the southeast corner of said SE/4 of SE/4 of NW/4; thence S 89°36'59" W along the south line of said NW/4 a distance of 202.00 feet; thence N 24°54'35" W a distance of 206.24 feet; thence N 89°20'37" E a distance of 286.72 feet to a point on the east line of said NW/4; thence S 00°39'23" E a distance of 189.00 feet to the point of beginning, containing 1.057 acres, more or less.

This property is also known as 120 Pruitt Road.

(If passed, must consider Emergency Clause.)

Mr. Kennemer spoke concerning the request of Mr. Tommy Epperly to rezone the property located at the northwest corner of Broadway and Pruitt Road. Mr. Kennemer explained the Long-Range Plan shows future land use at this intersection to be Light Industrial and the request of Mr. Epperly is compatible with Industrial Zoning, and was approved by the Planning and Zoning Commission.

Mr. Epperly addressed the Council concerning the five graves located on this property he owns, and his plans to relocate the graves as the law allows him to do so.

City Manager Holcomb advised the agreement with Tri-Stem Ltd., would allow them to conduct audits and study our prior utility billing and payments to determine that the amounts paid have been accurate.

Motion was made by **Councilman Nemecek** and seconded by **Councilman McCortney** to approve Consulting Agreement with Tri-Stem, Lt., to conduct audit and study of prior utility billing and payments, and to seek recovery of underpayments from utility providers. Mayor Morris called for the vote recorded as follows:

Discussion of and action on approval of Agreement with Hinderliter Geotechnical Engineering, LLC, to provide geotechnical engineering services for the proposed Police Station (13th/Townsend) and Fire Station (14th/Broadway) in the Not-To-Exceed amount of

\$9,500.00; approval for the Mayor to execute any and all necessary documents related to said agreement

City Manager Holcomb discussed the Agreement with Hinderliter Geotechnical Engineering, LLC, was to provide professional geotechnical services including soil borings, sub-surface, soil samples, bulk soil samples, bulk soil samples, groundwater data, and evaluation of moisture contents and report those findings. The City Manager explained it is necessary in order to finalize footing, slab and parking lot design criteria for both the proposed Fire Station and Police Station.

Motion was made by **Councilman McFarlane** and seconded by **Councilman McCortney** to approve Agreement with Hinderliter Geotechnical Engineering, LLC, to provide geotechnical engineering services for the proposed Police Station (13th/Townsend) and Fire Station (14th/Broadway) in the Not-To-Exceed amount of \$9,500.00; approval for the Mayor to execute any and all necessary documents related to said agreement. Mayor Morris called for the vote recorded as follows:

Discussion of and action on approval of a Revocable Telecommunications Cable Permit for Chickasaw Telecommunications Services, Inc., also known as Indian Nation Fiber Optics, allowing a right-of-way permit for fiber optic cable as follows (Job Number IJ14115):

Starting at existing HH#55, build south along the east side of North Monte Vista approximately 1200 feet, then turn west crossing North Monte Vista to 201 North Monte Vista Mercy Clinic. Pull a new fiber optic cable in the new conduit.

(Mercy Hospital to Mercy Clinic at 201 N. Monte Vista)

Motion was made by **Councilman Nemecek** and seconded by **Councilman McFarlane** to approve Revocable Telecommunications Cable Permit for Chickasaw Telecommunications Services, Inc., also known as Indian Nation Fiber Optics, allowing a right-of-way permit for fiber optic cable as follows (Job Number IJ14115. Mayor Morris called for the vote recorded as follows:

Mr. Jody Reader spoke to the Council concerning turning the old Kmart Building into a grocery store, such as comparable to Fire Lake in Shawnee. Also Mr. Reader suggested that Farmer's Market be moved to the parking lot of the old Kmart Building to allow for more room and safety for pedestrians.
